### House collapses in **Uttarakhand's** Pithoragarh after heavy rains, 2 trapped in debris

New Delhi Two persons were trapped in debris when their houses collapsed over them early on Monday morning following torrential rains in Bangapani sub-division of this Uttarakhand district

The incident occurred at Dhamigaon village in Bangapani-sub division, which had witnessed a cloudburst recently that killed 12 persons in Gaila and Tanga villages.

State Disaster Response Force (SDRF) and revenue police personnel were rushed to the village to launch rescue operations, Pithoragarh District Magistrate VK Jogdande said.

# India sees nearly 50,000 new coronavirus cases in a day, overall tally reaches 14.3 lakh

India has reported record 49,931 new coronavirus cases in the last 24 hours, taking the country's overall tally to 14.3 lakh on Monday morning.India also witnessed 708 coronavirus-related deaths in a day, taking the total Covid-19 fatalaties in the country to 32,771.

As per updated data by the Union Ministry of Health and Family Welfare, the total positive coronavirus cases in India stand at 14,35,453. This overall tally includes 4,85,114 active cases, while 9,17,568 have recovered, the health ministry said. The total number of confirmed cases also includes foreigners. The recovery rate in India has, meanwhile, improved to 63.9 per cent.

The total number of tests for detection of Covid-19 has crossed the 16 million-mark in the country. This is the fifth consecutive day when Covid-19 cases have increased by more than 45,000. India is now the third worst-hit coronavirus nation in terms of total cases after the US and Brazil.On Sunday, India's Covid-19 tally had climbed to 13,85,522, while the recoveries reached 8,85,576, according to the Union health ministry data.

# **Denied help to board** ambulance, suspected coronavirus patient dies in Bengal hospital

Amiddle-aged man in West Bengal's North 24 Paraganas died inside the hospital premises after he was allegedly refused help to board an ambulance, as he was a suspected coronavirus patient. The deceased, identified as Madhav Narayan Dutta, worked as a local grocery store shopkeeper, was taken to J.R. Dhar Sub Division Hospital in Bongaon district on Saturday evening after he faced difficulty in breathing and was admitted to Covid-19 ward.Later, he was referred to a hospital in Kolkata after his health condition deteriorated in the night.

# Karnataka ranks high in coronavirus data reporting, UP and Bihar worst: Stanford University study

New Delhi group of researchers from Stanford University has published a study that highlights major gaps and disparities in Covid-19 reporting by states and union territories in India. Bihar and Uttar Pradesh ranked worst in the Covid-19 data reporting, while Karnataka ranked best. However, the quality of Covid-19 reporting in India was only 0.26, which showed poor reporting across the country, found the study titled - 'Disparity in the quality of Covid-19 data reporting across India' - which is yet to be peer-reviewed. The research also found that only 10 states provided a visual representation of the trend in Covid-19 data, and 10 states did not report any data stratified by age, gender, comorbidities or districts. In addition, the researchers also stated that Punjab and Chandigarh compromised the privacy of individuals under quarantine by releasing their personally identifiable information on the official websites.Data reporting by states on coronavirusThe best data



reporting has been done by Karnataka (0.61), Kerala (0.52), Odisha (0.51), Puducherry (0.51), and Tamil Nadu (0.51).

Uttar Pradesh (0.0), Bihar (0.0), Meghalaya (0.13), Himachal Pradesh (0.13), and Andaman and Nicobar Islands (0.17) are at the bottom.Bihar and Uttar Pradesh did not publish any data on their government or health department website. Hence their Covid-19

Data Reporting Score (CDRS) is 0. Although, Bihar seems to release some data on Twitter.Karnataka and Punjab scored the highest in data availability. Both these states reported the daily and total numbers for confirmed, deceased and recovered cases. They also reported Covid-19 cases in Intensive Care Units (ICUs). Historical data is available for both the states in the form of daily

bulletins. Among the states that report data, Assam, Himachal Pradesh, and Meghalaya scored the lowest for availability. This is because they reported only the total count for confirmed, deceased, and recovered.

Covid-19 data can be accessed for 83 per cent of the states. Of the 10 states make the data more accessible by providing a visual representation of the trend, Karnataka and Kerala score the highest (0.75) in the accessibility category. These states provided trend graphics for both total and daily data, for the confirmed, deceased, and recovered cases.

In general, the worst categorical scores are for granularity. Even Jharkhand, the top state in this category, scored only a 0.50, while the median normalised granularity score is 0.17.Karnataka and Tamil First, it shows the lack of a unified Nadu are the only states to provide details of death (including comorbidity information) for each deceased person. States like Delhi, Andaman and Nicobar Islands, Andhra Pradesh, Bihar,

Chandigarh, Goa, Himachal Pradesh, Meghalaya, Telangana and Uttar Pradesh did not report any data stratified by age, gender, comorbidities, or districts, factors that are known to have a correlation with covid19 fatality rate, found the study.

from the state's official websites Impact of the shortfalls in Covid-19 data reporting: The study was conducted during the two-week period from May 19 to June 1, 2020. During this time, 29 states were assessed. In each state, the first case was reported at least 30 days prior to May 19.

> Hence, each of these states had at least a month's time before the assessment to build a high-quality data reporting system.

The disparity in CDRS across the states highlights three important findings at the national, state, and individual level:

## Assam flood situation worsens, people in Morigaon forced to live on roads: Ground report



**Morigain** The flood situation in Assam which has affected nearly 25 lakh people in 23 districts has remained grim, with five more persons losing their lives. Lakhs of people have been displaced by the deluge in Assam. While, Goalpara is the worst-hit with over 4.7 lakh people affected, around 3.33 lakh people have been hit by the deluge in Morigaon.

At present, 2,265 villages are inundated and people are forced to live in tents on a raised river embankment after being displaced or on the roads. The Centre said it was in constant touch with the state government and has committed to offer all possible help to mitigate the flood situation.

The authorities have distributed 4,451.99 quintals of rice, dal and salt, and 1,256.34 litres of mustard oil along with other relief materials such as tarpaulin, baby food, candle, matchbox, mosquito net, biscuit, soap, drinking water, cattle feed, mask, and wheat bran.India Today TV, too, has extended help in the flood-hit areas as many have remained displaced. Food packets, sanitizers, masks and sanitary napkins have been distributed among children and women.India Today TV team reached Barkhal village in Morigaon district which is completely submerged in water, leaving people stranded on roads. Like other districts of Assam, a boat is the only means of transportation here. Many are still trapped inside their houses. Moving towards his submerged house, Vipul Kumar, a local resident, told India Today TV how the flood broke many records this time Kumar acid, while the wester has time.Kumar said while the water has started receding, it will still take about a month for everything in the village to get normal. People have complained that the government's hel has not been enough.

At several relief camps, people have complained about negligence by the authority and claimed that they had received food grain only once upon their arrival about a week back. Speaking with India Today TV, women said they have nothing left at the moment.
