- 5. Particulars of the physical postal ballot forms received from the Members were entered in a register separately maintained for the purpose.
- 6. A total of 9 postal ballot forms received up to 5.00 p.m. on Wednesday, March 23,2022 the last date fixed by the Company, were considered for my scrutiny and kept under my safe custody. I did not receive any postal ballot form thereafter.
- On Wednesday, 23rd March, 2022 after the end of Remote e-voting period, a detailed voting summary report was generated from the portal of Central Depository Services Ltd ('CDSL') in the presence of two witnesses,
