- I. The name of the Company is SMRUTHI ORGANICS LIMITED.
- The Registered Office of the Company will be situated in the State of Maharashtra.
- III. The objects for which the Company is established are:
- A. MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE
- To carry on the business as manufactures, producers, refiners, processors, formulators, distributors, buyers, sellers, exports, importers or otherwise dealers in all classes and kinds of drugs, vitamins, pharmaceuticals, medicines, drug intermediates, foodstuffs for human and animal use, synthetic detergents surface active agents, dyewares, and without limiting the generality of the forgoings, the Sulphamethoxazole, Trimethoprim, sulphadiazine, Sulphaguanidine, Diloxanide Furoate, Salbutamol Sulphate, Theophylline, Ceffien, Aminophyllin, Norfloxacin, Ibuprofen, Metropidozole, Tinidozle, Nifidepine, Mebendazole, Chloropheniiramine Maleate, Niacinamide, Chloroquin Phospate, Pyrazinamide and other drugs,
- B. OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF MAIN OBJECTS:
- To manufacture, produce, refine process, formulate, buy, sell, export, import or otherwise deal in all types of heavy and light chemicals, chemical element's and compounds and other raw materials required in the pharmaceutical, drugs, medicine and chemicals.
- 3. To carry on the business of manufactures, importers, exporters, and as dealers in all kinds of pharmaceutical, medicinal and animal and vegetable oils, essential oils and flowers, essences and perfumery chemicals, salts glycerin fats, such as alcohols, acetone and vinegar etc. gelatin glue, water treatment chemicals, toilet requisites.
- 4. To carry on the business of chemists, druggists, importers, exporters manufacturers and dealers in pharmaceuticals, medical, and pharmaceutical preparations and compounds, drugs, dealers in chemical, surgical.
- To manufacture, produce, pack, repack, buy, sell, import, export and to carry on the business of vialing, bottling, packing, repacking and processing of capsule, syrups, tablets, injectibles, acrosoles and ointments.



- 6. To produce, manufacture, repair, formulate, import, export, trade buy sell, exchange, alter, manipulate, improve, prepare renovate, deal in or act in any other capacity in apparatus, machineries, plants, equipments, components, parts, fittings, assessors commonly used or capable of being use in connection with the pharmacentical, medicinal and chemical industry.

- 8. To investigate on behalf of any company. Corporation, corporate body, industry, firms associations or any persons and;

- 11. To construct, maintain and alter any buildings, or work necessary or convenient for the purposes of the company.
- 12. To purchase, take on lease or in exchange hire or otherwise acquire any real and personal property and any rights or privileges which the company may think necessary or convenient for the purposes of its business.
- 13. To open establish and maintain, shops offices, Factories, workshops, service-stations, branches and agencies for the purpose of the company in any part of India or elsewhere.

- 89. To carry on business as manufacturers, stockists, importers, exporters, repairers and dealers in dynamos, motors, armafures, magnets, batteries, conductors, insulators, transformers, comurters, switch boards, cookers, engines, guns, press insulating material, and generally electric plant, appliances and supplies of every description.
- 90. To carry on the business as manufacturers, dealers, stockists, importers and exporters, of buckets bath tubs, tanks trunk metal furniture safes, chimneys pipes.
